The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

1. RULES

- 1.1 The regatta will be governed by the rules as defined in the Racing Rules of Sailing (RRS).
- 1.2. The class rules of the IECU and the IECU Rules for major events will apply
- 1.3. RRS Appendix T, Arbitration, will apply.
- 1.4. RRS Appendix P, as changed by class rule 4.2, will apply.
- 1.5. [DP] RRS 40.1 applies at all times while afloat.
- 1.6. If there is a conflict between languages the english text will take precedence.

2. SAILING INSTRUCTIONS

The Sailing Instructions will be published on the event website

3. COMMUNICATION

- 3.1. The official notice board is located on the event website. Notices posted on the shed Notice boards are for the convenience of sailors only.
- 3.2. [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

4. [NP] [DP] ELIGIBILITY AND ENTRY

- 4.1 World Sailing eligibility as described in World Sailing Regulation 19 is required for all competitors. Only currently fully paid members of their National Europe Class Association that have been classified according with the national quotas may enter the regatta.
- 4.1.1 Boats and competitors of affiliated clubs or organizations to Russia (RUS) or Belarus (BLR) national authorities are not eligible to enter in accordance with World Sailing (WS) statement concerning the situation in Ukraine (https://www.sailing.org/)
- 4.2 The Youth European Championship will be held separately in men and women divisions.
- 4.3 For the Youth European Championship all the participants must have been born in 2004 or later.
- 4.4 For the Master European Championship male participants must have been born in 1988 or earlier (will be 35 in 2023), female participants must have been born in 1993 or earlier (will be 30 in 2023).
- 4.5 Competitors shall either have a valid sailing license, "Sport sailor license" or a valid official license prescribed or recommended for the sailing area. Members of other national federations shall have an adequate sailing license of their national authority.
- 4.6 Eligible boats may enter the event by registering online at the event website.





4.7 To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees until June 18th 2023. Later registrations are made with an increased fee and are not entitled to get a gift.

5 FEE

5.1 Entry fees are as follows:

- 5.2 The entry fee shall be paid to the bank account of BNP PARIBAS, BIC: PPABPLPK, IBAN: PL91 1600 1462 1839 5039 7000 0001 naming the event, sail number and name and surname .(the cost of transferring the starting fee is covered by the payer).
- 5.3 The entry fee shall be paid upon entering, even if the entry is canceled later or the boat does not show up. The entry fee is non-refundable, except for the event or class being canceled by the organizing authority or if the entry is rejected.
- 5.4 Entries for the Youth European Championship must be sent and paid before June 18th 2023. They shall be made by the sailors directly. Only qualified sailors may enter the event. Each National Europe Class Association has to send the list of the qualified sailors by email: prosport.ustka@gmail.com until June 18th 2023.

6 [DP] ADVERTISING

During the regatta, the organizer may require competitors to display sponsors' marketing materials.

8 [NP] [DP] EQUIPMENT INSPECTION

8.1 All competitors of the **Youth European Championship** will be inspected and must pass the measurement control.

The measurement control schedule will be posted on the event website no later than August 03th 2023.

- 8.2 A boat is required to submit the filled out internet inspection entry form as a printed document when registering for the measurement. The entry form will be available on the event website from July 14th 2023.
- 8.3 At any time the Technical Committee may require boats for inspection. Boats shall be presented fully rigged with all control lines in position.
- 8.4 Buoyancy, wet clothing, measurement and equipment checks may be made throughout the Regatta at the discretion of the IECU Representative, Race Committee, Technical Committee or the International Jury.
- 8.5 No first measurements will be made.

9 VENUE

- 9.1 The event will be hosted at Ustka as shown in addendum B and C.
- 9.2 The race office will be located at *Ustka Harbour* as shown in addendum B.
- 9.3 The racing area will be at the roadstead of the port of Ustka, Poland Addendum C shows the location of the race areas.

10 COURSES

The courses will be defined in the Sailing Instructions.

11 SCORING

- 11.1 Three valid races are required to constitute a championship.
- 11.2 There will be separate rankings for each Men and Women division with their categories according to the <u>IECU rules for major events 1.7.3.</u>
- 11.3 (a) When fewer than 4 races have been completed, a boat's series score will be the total of her race scores.
 - (b) When from 4 to 8 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
 - (c) When 9 or more races have been completed, a boat's series score will be the total of her race scores excluding her two worst scores.





11.4 If there are more than 80 participants in a division, the participants might be divided into further fleets. The composition of the fleets will be made as described in the Sailing Instructions.

12 [NP] [DP] SUPPORT PERSON VESSELS

- 12.1 All support person vessels shall be registered with the organizing authority. When support persons are present in the racing area, they are required to comply with local legislation and if applicable the 'Event Support Team Regulations', that will be posted on the event website. The organizing authority may refuse registrations and accept late registrations at their sole discretion. You can register here: https://forms.gle/zwHR9xZhtryLAXU77
- 12.2 Support persons shall wear personal flotation devices at all times while afloat, except briefly while changing or adjusting clothing or personal equipment.
- 12.3 The drivers of support person vessels shall use the kill cord at all times while the engine is running.
- 12.4 Support person vessels shall be insured with valid and for the racing area suitable third-party liability insurance with a minimum cover of 3.000.000 EUR per incident or the equivalent.

13 [DP] BERTHING

Boats shall be kept in their assigned places in the harbour.

14 [DP] BOATS AND EQUIPMENT

- 14.1 All competitors may enter only one hull, two sails, one mast, one boom, one center board, one rudder and one rudder head.
- 14.2 In the event of damage, boats and equipment may only be substituted with the written permission of the Race Committee. If the damage occurs later than 90 minutes before the first scheduled start on a racing day and before the start of the last race of the day, provisional verbal permission shall be obtained from the Regatta Measurer or Race Committee. The written permission shall be applied for before the end of the Protest Time at the day in which the substitution takes place.

15 [DP] MEDIA RIGHTS, CAMERAS AND ELECTRONIC EQUIPMENT

- 15.1 Upon registration to the event competitors agree that photos and videos may be taken of their person and used as part of the organizing authority's public relations activities, e.g. via websites, newsletters, print and tv media and social networks. In addition competitors or their guardians grant to the organizing authority without compensation the unlimited right to use images, photographs, television and radio material produced of them during the event.
- 15.2 Boats may be required to carry cameras, sound equipment and positioning equipment as specified and supplied by the organizing authority.
- 15.3 The top three competitors as well as the individual race winners may be required to attend a media press conference each day.
- 15.4 Competitors may be required to be available for interviews at the event.

16 DATA PROTECTION

The organizing authority will process and store personal data collected from entering and participating in the event. Addendum 1 "Data Privacy Policy" gives relevant information and details.





17. LIMITATION OF LIABILITY SALVATORY CLAUSE

- 17.1 The responsibility for the decision to participate in a race or to continue with it is solely with the skipper; to that extent the skipper also accepts full responsibility for the crew. The skipper is responsible for the qualification and the correct nautical conduct of the crew as well as for the suitability and the seaworthiness of the registered boat. In cases of force majeure or on grounds of administrative orders or for safety reasons, the organizer is entitled to make changes in the realization of the event or to cancel the event. This does not constitute any liability by the organizer towards the participant, if the reasons for the changes or the cancellation do not result from a willful or grossly negligent behavior of the organizer. In case of a violation of obligations that do not constitute main / essential contractual duties (primary obligations), the liability of the organizer for financial and property damages incurred by the participant during or in connection with the participation in the event and resulting from a conduct of the organizer, its representatives, servants or agents, is restricted to damages that were caused willfully or grossly negligent. When a violation of primary obligations occurs due to minor negligence, the liability of the organizer is limited to foreseeable, typical damages. To the extent that the liability for damages of the organizer is excluded or restricted, the participant also relieves the staff employees and representatives, agents, servants, sponsors and individuals who provide or drive salvage, safety or rescue vessels or assist with their use - from the individual liability for damages, as well as all other individuals who were instructed to act in connection with the realization of the event.
- 17.2. World Sailing's effective Racing Rules of Sailing (RRS), the constitution and regulations of Polish Sailing Association (PZŻ), especially it's regulations on regatta sailing, the class rules as well as the regulations of the Notice of Race and the Sailing Instructions are to be complied with and are expressly recognized.
- 17.3. Polish law applies.

18 [DP] INSURANCE

Each participating boat shall be insured with valid and for the racing area suitable third-party liability insurance with a minimum cover of 3.000.000 € per incident or the equivalent.

19 PRIZES

According to the IECU Rules for Mayor Events (R.1.7.), the first european qualified sailor in the overall result in both Men and Women division of the following categories:

- Youth (born in 2004 or later) will receive the "Gold medal" and be considered Youth European Champion of their category and division. The second will receive the "Silver medal" and the third the "Bronze medal". Prizes for the top 10 separately for women and for men.
- There will also be Medals for the best 3 "Junior" men and women (born in 2006 or later)
- Men (born in 1988 or earlier) and women (born in 1993 or earlier), Grand Master men and women (born in 1973 or earlier) Super Master men and women (born in 1963 or earlier) Legends men and women (born in 1953 or earlier) will receive the "Gold medal" and be considered European Champion of their category and division. The second will receive the "Silver medal" and the third the "Bronze medal".

Addendum I

PRIVACY DECLARATION FOR THE PARTICIPATION IN A REGATTA

§ 1 GENERAL

The staging of a regatta by the Sailing Club ProSport, Bobiecino 14, 77-200 Miastko necessitates the collection of data from all participants. Irrespective of whether you have registered by internet, by e-mail or in hard copy form, the protection of your personal information is of paramount importance to us. Therefore, we would like to inform you exactly which personal data provided by you is collected, further processed or otherwise used (collectively referred to as "processing") by us for the purposes of documenting our regatta.

§ 2 RESPONSIBLE BODY

The ProSport is responsible for the processing of personal data in the context of regatta participation. Further information about us, e.g. an e-mail address, can be found under para. 7 b of this declaration as well as the imprint on our website (www.ucsdays.com).

§ 3 PURPOSE AND LEGAL BASIS OF DATA PROCESSING

Insofar as personal data of participants is processed within the framework of the regatta participation, this is done for the performance and documentation of the regatta as well as for the fulfillment of our obligations towards class associations, the Polish Sailing Association or the respective national sailing associations. In addition, we may use your personal information in the context of fraud prevention and as evidence. Personal Data used for generating statistics (e.g. about the development of the number of participants) is strictly anonymized. The anonymized data and statistics are used solely for the respectively stated purposes. Where not specifically otherwise justified in the body of this statement, the legal basis for the processing of your personal data in the context of regatta participation is Article 6 para. 1 (b) of the general data Protection Regulation ("GDPR"). Should we use the data to prevent or to prove misuse, this is done on the basis of legitimate interest (Art. 6 para. 1 (f) GDPR). Please note that we will possibly be unable to process your registration if you do not provide us with the relevant personal data, the consequence of which will be that you will not be able to participate in the regatta. Insofar as you have given us consent for the processing of personal data for specific purposes (Article 6 para. 1 (a), 7 GDPR, e.g. for the production and publication of photos), we may process the data because your consent constitutes permission. You can revoke such consent at any time. Please note that the revocation affects only future activities. Any processing prior to the revocation is not affected.

§ 4 RELEVANT DATA

We process all data which you register and provide in the course of your registration for the regatta. These are data from the following categories: Master data (such as name, address, year of birth), boat number including national identification, club membership or other information voluntarily given by you. We only process photos/ videos of you in the event that you (or your parents on your behalf) have separately and specifically given us permission.

§ 5 COMMUNICATION OF YOUR DATA

-Responsible Persons To the extent that we are permitted, due to your participation in the regatta and by way of your consent or due to legal regulations, we communicate your data to third parties for the performance of the regatta. These third parties then process your data under their own





responsibility. The following persons and addressees, for example, can thus receive your data:

- adjudication officials or judges commissioned by us for the performance of the regatta.
- -Class associations, Polish Sailing Association, national sailing associations (e.g. for the purposes of ranking).
- -Public bodies and institutions (such as regulatory authorities) where a legal or regulatory obligation exists.
- -Other data recipients may be those for whom you have given us your consent to communicate the data.
- -Processors. When implementing and documenting the regatta, we engage external service providers who process personal data on our behalf ("processor"). Specifically, this includes companies in the following categories:
 - Technical service providers in the areas of IT and telecommunications (for example, hosting providers), print service providers.
 - Media and marketing service providers (e.g., web agencies, web designers).
 - Photographers / camera staff.

§ 6 DURATION OF DATA STORAGE

Your personal data is stored by us as far as and as long as this may be necessary in the context of the performance and documentation of the regatta or other processing purposes for which you have given your consent (e.g. photo use). In any event, the data is stored until the expiry of any appeal periods for protests in the context of the regatta or as long as your consent for the use of your personal data in the form of photos/ videos of you remains valid. Result lists are stored until at least the end of the calendar year in which the respective regatta took place. Should statutory or contractual retention periods, requiring further storage of your data as part of regatta participation, prevail beyond this point in time, we will also retain your data for these purposes beyond the end of the calendar year. Data for which there is no statutory or contractual retention obligation beyond the calendar year of the regatta date will be anonymized, unless you have expressly and concretely agreed to the further use of your data. Data for which no anonymization is possible is then destroyed or deleted.

§ 7 YOUR RIGHTS

- A) Right to Information, correction, restriction, deletion and communication. Upon request, we'll be happy to tell you which personal information is being processed by us. Should the data stored by us be erroneous, you are entitled to appropriate correction. You also have the right to block and delete the data stored by us, should the purpose for the processing of the data cease to exist or should other legal requirements prevail. In the event that the deletion contradicts legal or contractual retention or other statutory reasons, access to your data can be blocked but the data cannot be deleted. In addition, you have a right to have your data sent to you.
- B) Right of objection. You have the right, for reasons arising from your particular situation, to object at any time to the processing of your personal data taking place on the basis of a balance of interests (Article 6 para. 1 (f) GDPR). Should you file an objection, we will not process your personal information unless we can demonstrate compelling legitimate grounds for processing which outweigh your interests, rights and liberty, or for the purposes of asserting, pursuing or defending legal claims.

§ 8 UPDATING THE PRIVACY DECLARATION


