

Covid-19 Information and introductions

Techno293 European Championships 22.-28.08, Tallinn, Estonia

03.08.2021

It is the intention and goal of the Organizing Authority (OA) to hold this event as scheduled.

OA of the Techno293 European Championship is taking every step to meet our responsibilities to deliver a safe and controlled event and we adjust our actions and protocols to keep everyone safe in the Covid-19 pandemic.

Only the persons who have been either vaccinated, recovered from COVID-19, or presented a negative test result can take part in events and activities. This is not obligatory for children under twelve years of age.

Introductions:

- 1) Participants (both EU and non-EU), who have been vaccinated and present Vaccination Passports, should not do COVID 19 tests. **Take your Vaccination Passports with you!**
- 2) Participant, who does not have Vaccination passport can only attend the competitions if either up to 72 hours before arrival in the country a health care provider tested the person with a SARS-CoV-2 RT-PCR test **or** up to 48 hours before arrival in the country with a SARS-CoV-2 antigen RTD test **or** after arrival in the country performed at least one test for the coronavirus SARS-CoV-2 causing COVID-19, and the result negative for SARS CoV-2. Until the test has come back negative for SARS CoV-2 the person is required to remain in their place of residence or permanent place of stay. Registration can be completed only after the negative results have been presented to OA. **We urge you to do the test before entering Estonia, to avoid any negative surprises on site!**
- 3) **Traveller's questionnaire.** All passengers arriving in Estonia by air (including children for whom the data is provided by their parent) must fill in the [traveller's questionnaire](https://iseteenindus.terviseamet.ee/) (<https://iseteenindus.terviseamet.ee/>) before arriving in Estonia. You can do this up to three days before arriving in Estonia. The border guard or the airline may ask for confirmation of the border crossing declaration sent by e-mail either electronically or on paper. Those arriving by ship, bus, car or train are obliged to fill in the traveller's questionnaire when arriving from a [country marked in red in the table](#).
- 4) **Anyone from non-EU countries must provide the following information to Organising Authority by e-mail (kristel@purjelauliit.ee) at least 7 working days before your arrival to Estonia:**
 1. Full name
 2. Passport Number
 3. Passport issued on
 4. Passport valid until
 5. Date and place of Birth (as appears in Passport)
 6. Date and time of crossing the border
 7. Point of entry
 8. Kind of transport (plane, car, s/y)

9. Departure date

This information will be sent to the Estonian Police and Border Guard Board by the Organising Authority ahead of your arrival.

If you do not send the information at least 7 working days before your arrival to Estonia to kristel@purjelaualiit.ee , your entry to Estonia and participation at the European Championships could be hindered .
